I'd love for you to get the best possible results from your treatment, so before we proceed any further, please read and make yourself aware of the **IMPORTANT INFORMATION** opposite.

If you have any **MEDICAL CONDITION** and are under doctors' supervision you will be required to show a letter from your GP to prove that you are suitable for this semi-permanent, make up treatment.

If you have any **MEDICAL CONDITION** that you believe may affect the treatment, please ensure you contact me to discuss this as soon as you receive this email.

Sorry, but I cannot perform the procedure if you are pregnant or nursing.

Failure in letting me know of any medical condition that could affect the treatment, may result in poor results, cancellation of your booking and loss of deposit.

The Important Stuff!

- ✦ If you suffer with glaucoma, the treatment involves some mild pressure around the eye area, which could complicate your condition further.
- ✦ If you have had eye surgery, you should only have treatment 3 month post op.
- ✦ Please avoid alcohol and caffeine prior to the procedure.
- ✦ No sun, sun beds, sweating, or tanning prior to the procedure or after, for 14 days.
- ✦ Please do not work out on the day of the procedure. It is recommended not to sweat for the first 14 days after the procedure!
- ✦ If you have botox, it should be performed either 8 weeks prior, or 8 weeks after your treatment.
- ✦ **DO NOT** take Aspirin, Niacin, Vitamin E and / or Ibuprofen unless medically necessary, 48-72 hrs. prior to your procedure.
- ✦ You **SHOULD NOT** have this procedure if you are taking Accutane.
- ✦ **DO NOT** have facials, chemical peels, LED treatments or use Glycolic acid, 4 weeks prior to your semi-permanent make-up procedure. You **MUST** be off Retin-A or Retinols for 7 days prior to your appointment and avoid using on or around the area for 30 days after.
- ✦ **DO NOT** use eyelash growth serum on lashes 2 weeks prior to your treatment.
- ✦ Dark skin types please note that your permanent makeup will not appear as bold as lighter skin types. (Indian, African American, Filipino, etc.)
- ✦ Please attend make-up free, removing false lashes and contact lenses beforehand. It is recommended not to use contact lenses for 48 hours after.
- ✦ For optimum results, we recommend a lash lift and tint beforehand. This must be at least 4 days prior to your appointment.

These measures have been put in place for your safety and to ensure the best possible results. I want you to leave the salon feeling completely happy with your new brows!

A £50 deposit is required to secure your appointment

All deposits paid are non-refundable. However, deposits will not be lost if you re-schedule your appointment within 72-hours. The deposit amount will be deducted off your final bill on the day.

A patch test will be required. This can either be sent to you by post for you to perform at home (once the pigment has been applied, I will require a photo for your medical records), or get in touch and I can do this for you at the salon.

What Next?

Once you have had your treatment, I will thoroughly explain the aftercare procedure. You will also receive instructions in the form of a handy booklet that you can refer to at home, along with some little aftercare goodies to help keep your eyeliner on point!
